It will pay \$1,000 for the winner of each round and \$10,000 purse. WSTR Rules/ Dress Code in effect. WSTR/USTRC card to rope. All horses must go through the sale before prize money is given, no-shows will be \$350 per horse. All sell with reserves; no "no-sales" in the ring. 8% Commission. Sale proceeds will be held until all necessary paperwork is in the CHS office, otherwise settlement will be made on Friday after the sale. All catalog fees must be paid at time of entry. All guarantees are between the buyer & seller. All horses are presumed to be sound which means sound of limb & wind with all vices declared including cribbing, weaving and all other undesirable traits. CHS is strictly an agent but we require full disclosure of all faults and defects. CHS is not responsible for sickness or accident. Consignor letters will be emailed 3 weeks before the sale/catalogs mailed to consignor 2 weeks prior to the sale. It is your responsibility to get your horse to and from the sale ring at its designated time. Bring your feed/water buckets.
